3.1 FEES FOR TRAINING AT INDIVIDUAL TIME

In the case of training at a specific time requested by a clearing member, the fees under point 1.1 will be charged at a 50% surcharge

Comments:

• Courses start with a minimum of 5 participants, in case of the ICS monitors application user training with a maximum of 9 participants. GIRO Zrt. will provide the training courses upon

individual request of the Clearing member with a minimum of 5 participants or for a fee per 5 participants.

- The fee of the in-person training held in the office of GIRO Zrt. includes all the equipment needed for the training (course material, in case of ICS monitors application user training individual workstation for each participant), the certificate and the catering (refreshments, coffee, tea, lunch).
- Any request for training at a time initiated by a Clearing Member must be notified in writing to the Clearing Member at least 30 days in advance, specifying the number of participants and the planned date of the training
- In the case of training held at an off-site location, GIRO Zrt. will provide training material, printed training material and certificates on a laptop, the projection equipment will be provided by the customer..

2 TESTING

2.1 FEES FOR TESTING ON PRE-DETERMINED DAYS

Testing: clearing system usage fee includes the fee for testing on days pre-determined by GIRO Zrt.

2.2 FEES FOR TESTING AT A SPECIFIC TIME

If a Clearing Member or Customer does not wish to perform its testing tasks on the predetermined testing days, it must submit an individual request in writing to GIRO Zrt. 30 (thirty) days prior to the scheduled testing date. The Clearing Member is required to indicate in the request if it requires the involvement of GIRO Zrt. in the distribution of the transaction. (If required, GIRO Testbank will participate in the test in a sending role, the reception of transactions by GIRO Testbank does not require the active involvement of GIRO Zrt.)

After consultation with the applicant, GIRO Zrt. may grant or reject the request.

Fees for testing at a specific time:

- on working days, when using the IG1 or IG2 platform:
 - GIRO Testbank in sending role: 200.000,- HUF + VAT/Settlement date,
 - without involvement of GIRO Zrt.: 150.000,- HUF + VAT/Settlement date
- on working days, for both IG1 and IG2 platforms:
 - GIRO Testbank in sending role: 300.000,- HUF + VAT/Settlement date,
 - without involvement of GIRO Zrt.: 225.000,- HUF + VAT/Settlement date

- on working days, when using the GIROInstant platform 1:
 - GIRO Testbank in sending role between 8 am and 5 pm 200.000,- HUF + VAT/Settlement date,
 - without involvement of GIRO Zrt.: clearing system usage fee includes.

on public holidays², the price on working days is subject to a 100 % surcharge.

3 Statistical data reporting

3.1 REGULAR DATA REPORTING

In case of an order, GIRO Zrt. provides the statistical data regularly from the month indicated in the order until the month indicated in the withdrawal. No earlier month than the month following the date of the withdrawal may be specified in the withdrawal.

The GIROInstant supplementary data service is available to subscribers to the statistical reporting service, which contains additional information on instant payments in the reference month, broken down by item.

GIRO Zrt. will send the requested list(s) to the GIROMail Central mailbox of the Clearing Member. If the Clearing Member does not request the list(s) to be sent via GIROMail, GIRO Zrt. will charge an additional fee in addition to the list fee.

In the event of a request for amendment to the UGIRO Catalogue of the Central Registry received after the deadline for the closure of the catalogue, an Extraordinary UGIRO Catalogue will be issued, for which GIRO Zrt. will charge a fee.

At the initiative of the Clearing Member, the GIRO Zrt. shall provide expert consultation opportunities to discuss any issues arising in connection with the clearing system.
